

General information

The Country Coordinating Mechanism for Interaction with the Global Fund to Fight AIDS, Tuberculosis and Malaria (hereinafter referred to as the CCM) is a standing committee that develops and submits national funding applications to the Global Fund to Fight AIDS, Tuberculosis and Malaria (hereinafter referred to as the Global Fund), coordinates joint activities of the government agencies, other state organizations subordinate to the Government of Belarus and other organizations (hereinafter referred to as state and other relevant organizations) in the framework of its cooperation with the Global Fund.

The CCM activities are based on the existing principles of planning at the national level and consistent with the National HIV Prevention Programme.

In its activities, the CCM is guided by the Constitution of Belarus, other legal acts, the CCM Guidelines and international agreements for HIV and tuberculosis prevention.
